## Planned Giving Opportunities

### There are several ways you can support the mission of Cross Roads beyond your annual contributions to the General Fund.

The **HONORS AND MEMORIALS** program supports current special needs at Cross Roads. Gifts may be made in honor of special occasions (Valentine's Day, birthdays, anniversaries) or to recognize a kindness or achievement. They may also be made in memory of a special person. The form is available in the Church office and included in the monthly *Herald*. You may select the **Special Needs** fund that is most meaningful to you:

- General Fund
- Landscaping
- Children's Ministries
- Undesignated Planned Giving
- Special Music
- Scholarship
- Food Pantry

You may also designate gifts for a **Church Endowment**. Interest from endowments provides support for our congregation:

- General Endowment
- Music Maintenance
- Pastor's Housing

\* Other special gifts may be accepted with Session approval.

### PILLARS OF CROSS ROADS

We invite you to have lasting impact on our Church by including Cross Roads in your gift and/or estate plans. Your enduring statement of faith will be used to further Christ's work and will have an impact on future generations of our church family.

Individuals who have included our Church in their gift or estate plans are eligible for the **Pillars of Cross Roads** Program, which recognizes people who have made or who are making bequests, estate plans or irrevocable gifts. The Pillars of Cross Roads plaque is located in the Narthex.

The **Presbyterian Foundation** provides services to our church and can provide you with valuable information on a wide variety of planned giving options available to individuals who are considering estate planning opportunities. A development officer is available to confidentially discuss options for funding a mission at our church.

A **Will** is the cornerstone of an estate plan. A will can proclaim your Christian faith and demonstrate your response as a faithful steward to future generations.
